I/We declare that we have disclosed fully in writing all information relating to the application which I/we know or should reasonably know and which is relevant or material for the purpose of assessment.

The provision of personal data is entirely voluntary. If you do not provide sufficient information, we may not be able to prove your eligibility for specific services/activities, to accede to your request or to conduct an in-depth investigation into a complaint case, and hence cannot provide services/assistance to you.

### **Classes of Transferees**

2. The personal data provided by you are mainly for use within the Department of Health but they may also be disclosed to other Government bureaux/departments or relevant parties for the purposes mentioned in paragraph 1 above, if required. Apart from this, the data may only be disclosed to parties where you have given consent to such disclosure or where such disclosure is allowed under the Personal Data (Privacy) Ordinance.

### **Access to Personal Data**

3. You have the right of access and correction with respect to personal data as provided for in sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. Your right of access includes the right to obtain a copy of your personal data. A fee may be imposed for complying with a data access request.

## 「星級有營食肆」櫥窗標貼 / 宣傳品使用及展示細則

「星級有營食肆」櫥窗標貼 / 宣傳品只供參與「星級有營食肆」運動的食肆（參與食肆）使用，參與食肆必須同意及遵守「星級有營食肆」櫥窗標貼 / 宣傳品的使用及展示細則。

### 1. 擁有權

- 「星級有營食肆」櫥窗標貼 / 宣傳品的擁有權，概為衛生署所有。
- 參與食肆不得未經衛生署同意下將有關櫥窗標貼 / 宣傳品複印、複製、編輯、外借或給予任何第三者。
- 該櫥窗標貼 / 宣傳品只能作為健康教育及推廣用途。

### 2. 使用模式

- 「星級有營食肆」櫥窗標貼 / 宣傳品必須以原格式展示及使用，參與食肆不可擅自複印或更改其形狀、大小或顏色。

### 3. 展示位置

- 櫥窗標貼只可展示於「星級有營食肆」的店舖前或其他當眼位置。

### 4. 數量

- 每間「星級有營食肆」只會獲發一個註有編號的櫥窗標貼。

### 5. 申領宣傳品的程序

- 署方收取表格後，將在十個工作天內審核申請。

### 6. 更換櫥窗標貼

- 參與食肆會每兩年換上新的櫥窗標貼，屆時將會收到秘書處發出的通知。
- 參與食肆於換上新的櫥窗標貼後，請立即將舊的櫥窗標貼銷毀。

### 7. 交回「星級有營食肆」櫥窗標貼 / 宣傳品

- 「星級有營食肆」標誌必須原裝展示及使用，參與食肆不得更改標誌的內容。
- 參與食肆必須展示「星級有營食肆」標誌，以提供產品資訊及銷售點推廣資訊，以便顧客選擇健康菜式。
- 當參與食肆在其製造或售賣的食品使用及展示「星級有營食肆」標誌，並不表示此等產品已獲衛生署核准、認可或批准。

### 3. 申請在宣傳物料中使用「星級有營食肆」標誌

- 參與食肆如欲申請在餐牌以外的其他宣傳物料使用該標誌，必須填妥《「星級有營食肆」索取宣傳品表格》，連同有關的全彩色美術設計圖經秘書處提交衛生署審批。
- 署方接獲齊全的申請文件後，將在十個工作天內審核申請。
- 署方將按個別情況准許參與食肆使用或展示「星級有營食肆」標誌。

### 4. 終止

- 如食肆退出「星級有營食肆」運動，必須立刻停止使用「星級有營食肆」標誌，並於十個工作天內交還秘書處。

## Conditions for Use and Display of “EatSmart Restaurant Star+” Decal/Publicity Materials

The “EatSmart Restaurant Star+” Decal/publicity materials is/are only for use by restaurants participating in the “EatSmart Restaurant Star+” Campaign (participating restaurants). Participating restaurants must agree and comply with the conditions for use and display of the “EatSmart Restaurant Star+” Decal/publicity materials.

### 1. Ownership

- The “EatSmart Restaurant Star+” Decal/publicity materials is/are the properties of the Department of Health (DH).
- Participating restaurants shall not copy, reproduce, edit, lend or give the Decal/publicity materials to any third parties without the consent of the DH.
- The Decal/publicity materials should be used for health education and promotion purposes only.

### 2. Usage Format

- The “EatSmart Restaurant Star+” Decal/publicity materials shall be displayed and used in the original form and shall not be copied or modified in shape, size or colours.

### 3. Display Location

- The Decal can only be displayed at the shop front or other prominent location of the participating restaurants.

### 4. Decal Quantity

- Each participating restaurant will only be given one Decal marked with a number.

### 5. Procedures to Apply for Publicity Materials

- To request for “EatSmart Restaurant Star+” publicity materials, participating restaurants shall complete the “‘EatSmart Restaurant Star+’ Campaign – Publicity Materials Order Form’ and submit it to the Secretariat.
- Upon receipt of the order form, the Secretariat shall review the application within ten working days.

### 6. Replacement of Decal

- Participating restaurants have to replace their Decal with a new one every two years. They will be informed by the Secretariat in due course.
- Participating restaurants are required to dispose of their old Decal immediately upon replacing it with the new one.

### 7. Return of “EatSmart Restaurant Star+” Decal / Publicity Materials

- Upon withdrawal from the “EatSmart Restaurant Star+” Campaign, restaurants shall immediately discontinue the use/display of the Decal/publicity materials and return it/them to the Secretariat as soon as practicable.
- The DH may at any time request the immediate return of the “EatSmart Restaurant Star+” Decal / publicity materials from participating restaurants on the conditions specified in “EatSmart Restaurant Star+” Campaign – Guidance Notes for Participating Restaurants’.


The DH reserves the right to impose other terms and conditions for use and display of the “EatSmart Restaurant Star+” Decal/publicity materials at any time as appropriate by which participating restaurants must abide.


## Conditions for Use of “EatSmart Restaurant Star+” Logos


The “EatSmart Restaurant Star+” Logos are only for use by restaurants participating in the “EatSmart Restaurant Star+” Campaign. Participating restaurants must agree and comply with the conditions for use and display of the “EatSmart Restaurant Star+” Logos.

### 1. Ownership

- The “EatSmart Restaurant Star+” Logos are properties of the DH. They include:

“Dish with More Fruit and Vegetables” Logo 

“3 Less Dish” Logo 

“EatSmart Promotion” Logo 

- Participating restaurants shall not copy, reproduce, edit, lend or give the “EatSmart Restaurant Star+” Logos to third parties without consents or permissions from DH.

### 2. Usage

- The “EatSmart Restaurant Star+” Logos should be used for health education and health promotion purposes only.
- The “EatSmart Restaurant Star+” Logos shall be displayed and used in whole and the content of logos cannot be altered.
- The “EatSmart Restaurant Star+” Logos shall be displayed to provide product information and point-of-purchase promotional information to facilitate customers’ selection of healthy dishes.
- The use and display of the “EatSmart Restaurant Star+” Logos on food products manufactured or sold by participating restaurants do not mean that such products are certified, endorsed or approved by the DH.

### 3. Request for Approval on Use of “EatSmart Restaurant Star+” Logos in Publicity Materials

- To request for the approval on the use of “EatSmart Restaurant Star+” Logos in other publicity materials other than food menus, participating restaurants should complete the “‘EatSmart Restaurant Star+” Campaign – Publicity Materials Order Form’ and submit it together with the artwork in full colour to the Secretariat for approval by the DH.
- Upon receipt of all the required documents for application, the DH shall review the application within ten working days.
- The DH shall approve the use or display of the “EatSmart Restaurant Star+” Logos by the participating restaurants on a case-by-case basis.

### 4. Cessation

- Upon withdrawal from the Campaign, participating restaurants shall immediately discontinue the use of “EatSmart Restaurant Star+” Logos and return them to the Secretariat within ten working days.

The DH reserves the right to impose other conditions for use of the “EatSmart Restaurant Star+” Logos at any time as appropriate by which participating restaurants must abide.
